adora birth + wellness ("Adora", "we", "our") is committed to maintaining the accuracy, confidentiality and security of your personal information. Adora provides to its clients, as requested, doula services including pregnancy, labour and postpartum support, birth photography, and access to a third party pregnancy companion application 'The Journey' ("Services"). In providing the Services, Adora may collect, use, and disclose your personal information as is reasonably required for the provision of the Services.

This Privacy Policy describes how your personal information is collected, used, and disclosed by Adora. This Policy also applies more generally to the personal information of all individuals with whom Adora interacts including clients, community partners, contractors, employees, and other individuals.

By accessing or using our website located at www.adorabirthandwellness.com or any of its pages ("Site") or by using our Services, you signify that you have read, understood, and agree to our collection, storage, use, and disclosure of your personal information as described in this Privacy Policy, our Terms of Service, and any third party terms and privacy policies relating to "The Journey', as applicable. If you do not agree to any of the Privacy Policy, our Terms of Service, or any third party terms and privacy policies relating to 'The Journey', as applicable, please do not access or use our Site or use the Services.

#### What Is Personal Information?

### What Information Do We Collect?

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information

For example, if you enter vomiting or blood pressure readings into 'The Journey', it is implied that you have granted Adora permission to use such information. From time to time, we may utilize the services of other third parties in our business and may also receive personal information collected by those third parties in the course of the performance of their services for us or otherwise. Where this is the case, we will take reasonable steps to ensure that such third parties have represented to us that they have the right to disclose your personal information to us.

### Do we share the information we collect with third parties?

We may share the information that we collect with our current and future affiliated companies, third party service providers, and business partners, and if we are involved in a merger, asset sale or other business reorganization, we may also share or transfer your personal and non-personal information to our successors-in-interest. If your personal information is shared with any such third parties, we will require such third party to protect your personal information in a manner consistent with this policy and to limit the collection, use and disclosure of such information to that which is reasonably required for the performance of the third party service for Adora.

### **How Do We Use The Information We Collect?**
